### Evaluation

- Our PAT level of excellence is 8.8% higher than the provincial average and is deemed to be a high level of achievement.
- We have maintained an intermediate measure of acceptable standard for our PATs, and have exceeded the provincial average by 6%.
- Our grade 9 PAT results in both the acceptable and excellence categories are deemed to be low due to the very low number of eligible writers and non-participation in PATs by our e-learners.

- SJF has implemented a new character education program for the 2024-25 school year which should lead to some improvements in this area.

- The overall measure for access to supports and services increased by 3.3% which resulted in an improved evaluation.
- Improvements were made in all three categories: Student 3.4%, Parent 5.6%, and Teacher 4.8%.
